Ms Danielle Hika, Deputy Registrar: I refer to previous evidence at 370 Aotea MB 183-191 dated 19 May 2017 where the Court adjourned the above application to await:

- confirmation in writing from Kahurangi Hippolite that she has resigned as a trustee; and
- receipt of a signed trustee consent form for Nina McGregor and evidence of her successful nomination as a responsible trustee at a meeting of owners.

Once this information was to hand the application was to be referred to Chambers for the making of orders.

On 14 June 2017 Nina McGregor filed a fully completed consent form together with a copy of Annual General Meeting minutes dated 29 September 2012 where her nomination as a responsible trustee was made.

On 16 June 2017 an email was received from the applicant which included a response from Kahurangi Hippolite regarding her resignation as a trustee. The applicant advised that he would make further enquiries with whānau in an attempt to obtain contact details for Ms Hippolite.

On 2 August 2017 the applicant advised that he had exhausted all avenues and has been unsuccessful in obtaining contact details for Ms Hippolite.

On 21 August 2017 the case manager received an email from Kahurangi Hippolite confirming her resignation and her wish to be removed as a trustee.

Therefore, it is recommended that the Court make an order replacing Nelson Nerehana Tepu, Wayne Gilbert Taylor and Kahurangi Hippolite, who have resigned and Percival Te Awhina Nicholson who is deceased with William McGregor, Kim Taylor and Nina Esther May McGregor as responsible trustees of the Manawatu Kukutauaki No. 3 Section 2B1 Trust and the Manawatu Kukutauaki No. 3 Section 2E5 Trust.

Orders are sought as noted above.

The Court makes an order pursuant to section 239 of Te Ture Whenua Māori Act 1993, appointing William McGregor, Kim Taylor and Nina Esther May McGregor as replacement responsible trustees for Nelson Nerehana Tepu, Wayne Gilbert Taylor, Kahurangi Hippolite and Percival Te Awhina Nicholson of the Manawatu Kukutauaki No. 3 Section 2B1 Trust and the Manawatu Kukutauaki No. 3 Section 2E5 Trust.

For the avoidance of doubt the trustees are the newly appointed trustees together with Ann Elizabeth Taylor, Te Kenehi Teira, Martin Robert Howard Taylor, John Arona McGregor and Wayne Rangi Nicholson.

The foregoing order to issue immediately pursuant to rule 7.5(2)(b) of the Māori Land Court Rules 2011.
